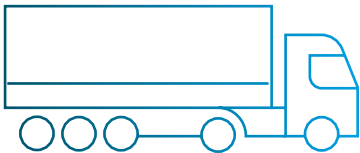

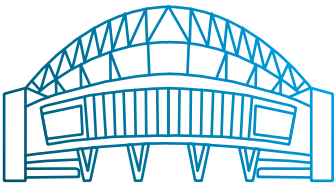

With seamless access to Adelaide’s freight network, Airport Junction is perfectly located to offer unmatched efficiencies for businesses.



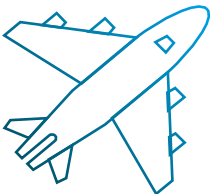
B-Double road access to North-South Connector

As part of the development works, a new B Double loaded roadway will be delivered, **connecting the precinct directly to Adelaide’s future North-South Corridor**, via Richmond Road. This access provides new unlocked efficiencies for road freight networks.

Runway to Road
