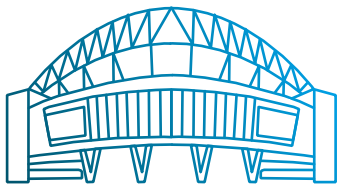
Adelaide Airport's Catalyst Park is an industrial precinct designed for businesses leading the way in developing tomorrow's technology

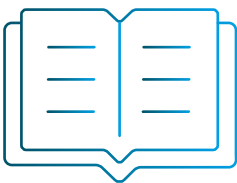
6km to the Adelaide CBD

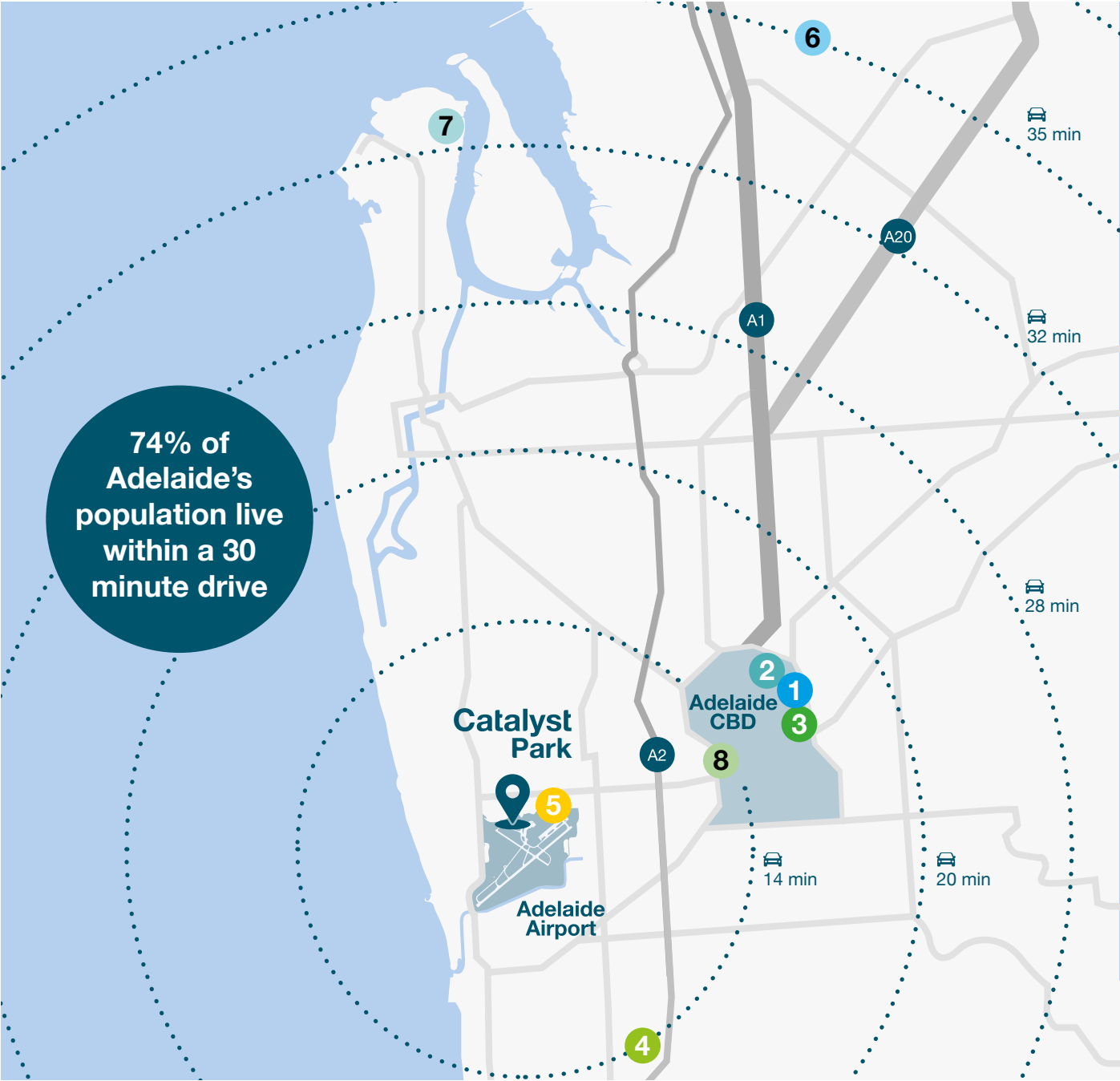
1.4km to Adelaide Airport terminal
